is then sent by the court to a transcriber who will contact you to make separate financial arrangements to obtain a copy of the completed transcript). Requests filed electronically require payment on-line by credit card at the time of filing. Other requests must be accompanied by check or money order made payable to "Clerk, U.S. Bankruptcy Court". (*Pursuant to Miss. Bankr. L.R. 5001-1(f)*,

checks or credit cards of the debtor will not be accepted.)
