#### Federal Bankruptcy Rules Proposed Amendments – December 1, 2021

### Rule 2005 – Apprehension and Removal of Debtor to Compel Attendance for Examination

- (c) Conditions of Release.
  - Amended to provide that in setting conditions to assure a debtor's appearance at certain proceedings, the court should consider "relevant" provisions of 18 U.S.C. § 3142.
  - Updates an outdated statutory reference to 18 U.S.C. § 3146 and limits the consideration to only "relevant" provisions of this statute that addresses conditions to assure a criminal defendant's attendance at trial.

#### Federal Bankruptcy Rules Proposed Amendments – December 1, 2021

### **Rule 3007 – Objections to Claims**

- (a) Time and Manner of Service.
  - Subsection (a)(2)(A)(ii) amended to clarify that the special service method required by Rule 7004(h) must be used for service of objections to claims only on insured depository institutions as defined in section 3 of the Federal Deposit Insurance Act.
  - Eliminates interpretation that service pursuant to 7004(h) applies to credit unions insured by the National Credit Union Administration.

#### Federal Bankruptcy Rules Proposed Amendments – December 1, 2021

### **Rule 7007.1 – Corporate Ownership Statement**

 Amended to extend the corporate disclosure requirement to nongovernmental corporations that <u>seek</u> to intervene in an adversary proceeding.

### Federal Bankruptcy Rules Proposed Amendments – December 1, 2021 Rule 9036 – Notice and Service Generally by Electronic Transmission

- Subsections added to separate methods of electronic noticing and service available to the <u>courts</u> from those available to <u>parties</u>.
- Both may serve or provide notice to registered ECF users by filing documents with the system.
- Both may serve and provide notice to any entity by electronic means consented to in writing by the recipient.
- Only courts may serve or give notice at an electronic address registered with the Bankruptcy Noticing Center (BNC) as part of the noticing program.

# **CM/ECF Filing Tips and Reminders**

- <u>PLEASE</u> Contact Clerk's Office with Questions;
  E.g., Filing requirements, Corrective action;
- Pleadings with Multiple Reliefs Select All Events; Some events must be filed separately;
- Generic Motion Event Not for Common Use; Use when no event "fits" your filing;
- Presumption of Abuse = <u>Unknown</u> if Means Test Not Filed with Voluntary Petition;
- Amend Creditor Matrix = Update Creditor Database

Southern District of Mississippi

- Pay close attention to notices regarding hearings:
  - In-person,
  - Telephonic,
  - Video (from the courtroom), or
  - Online video teleconference (i.e. Zoom).



Southern District of Mississippi

- In-person hearing (in the courtroom)
  - Mask required in courthouse (judge discretion in courtroom)
  - Social distancing required in courtroom
  - Ten-person limit in courtroom (not including court staff)
  - Compliance with District Court Special Order required



Southern District of Mississippi

- Telephonic hearings
  - Dial in at least 10 minutes before hearing
  - Land line strongly preferred
  - Do not use speaker phone
  - Headset microphone recommended
  - Keep line muted when not talking
  - Identify yourself each time you speak
  - Do not record the call

- Video hearings (in courtroom)
  - See in-person hearing requirements

- Ensure that you have a good quality internet connection.

  - Headset microphone preferred over computer microphone
  - Connect at least 10-15 minutes before hearing to check connection, etc.
  - Make sure that you are **muted** (and remember to unmute when you need to speak)
  - Identify yourself each time that you speak
  - Do not record the video or audio
