# Federal Bankruptcy Rules

Pending Amendments – December 1, 2021

## Rule 2005 – Apprehension and Removal of Debtor to Compel Attendance for Examination

### (c) Conditions of Release.

- Amended to provide that in setting conditions to assure a debtor's appearance at certain proceedings, the court should consider "relevant" provisions of 18 U.S.C. § 3142.
- Updates an outdated statutory reference to 18 U.S.C. § 3146 and limits the consideration to only "relevant" provisions of this statute that addresses conditions to assure a criminal defendant's attendance at trial.

# **Federal Bankruptcy Rules**

## **Pending Amendments** – December 1, 2021

### **Rule 3007 – Objections to Claims**

#### **(a) Time and Manner of Service.**

- Subsection (a)(2)(A)(ii) amended to clarify that the special service method required by Rule 7004(h) must be used for service of objections to claims only on insured depository institutions as defined in section 3 of the Federal Deposit Insurance Act.
- Eliminates interpretation that service pursuant to 7004(h) applies to credit unions insured by the National Credit Union Administration.

# Federal Bankruptcy Rules

Pending Amendments – December 1, 2021

## Rule 7007.1 – Corporate Ownership Statement

Amended to extend the corporate disclosure requirement to nongovernmental corporations that seek to intervene in an adversary proceeding.

Previous disclosure requirement – any nongovernmental corporation that is a party to an adversary proceeding, other than the debtor.

# Federal Bankruptcy Rules

Pending Amendments – December 1, 2021

## Rule 9036 – Notice and Service ~~Generally~~ by Electronic Transmission

- Subsections added to separate methods of electronic noticing and service available to the courts from those available to an entity.
- Both may serve or provide notice to registered ECF users by filing documents with the system.
- Both may serve and provide notice to any entity by electronic means consented to in writing by the recipient.
- Only courts may serve or give notice at an electronic address registered with the Bankruptcy Noticing Center (BNC) as part of the noticing program.

## Advantages:

- **Free** – No charge to the Debtor.
- **Fast** - Receive certain court orders/notices same day as filed.
- **Convenient** – Access anywhere with internet access.
- **Go Green** - Less paper.

**Notices and orders filed by the court will be emailed to debtor.**

- Attorneys, trustees, and creditors must continue to serve debtor as required by court rules.

## **Request Debtor Email Notification:**

- See court website to download necessary local form.

### CM/ECF Filing Tips and Reminders

- PLEASE don't hesitate to Contact Clerk's Office:  
(ECF Requirements, Corrective action inquiries, etc.)
- Amend Creditor Matrix = Update Creditor Database;
- Notice of Appearance and Request for Notices:  
Add Party and Attorney/Filer to Case;
- Generic Motion Event – Not for Common Use;  
Use when no event “fits” your filing;
- Pleadings with Multiple Reliefs – Select All Events;  
Certain events must be filed separately;

### CM/ECF Filing Tips and Reminders

- Want to Reopen a Case to File a Pleading?
  - File Motion to Reopen First and Separately
  - File Pleading after Order Reopening Case Entered
- Fees are Statutory (See 28 U.S.C § 1930);
  - Do not add “fee” event to docket text of “non-fee” event as alternative relief;
  - e.g., Motion to Dismiss Case *or in the alternative Motion for Relief from the Automatic Stay*;

### **Why Corrective Action Requests???**

#### **Procedural Requirements/Docket Management Issues**

##### **Common Example - Multiple Remedies:**

- 21-Day Notice? 28-Day Notice? 30-Day Notice?
- Court to Issue Notice of Response Deadline Only?
- Court to Issue Hearing Notice?
  - Who will serve parties? Court or Filer?

##### **Common Issue - Proper Tracking or Record of Disposition**

- ECF entries provide electronic tracking tools;
- Order entries generally notate disposition and terminate tracking for filings (e.g., grant, deny, overrule, sustain, conditional, in-part, etc.);

# COVID Update

- Most hearings are in person.
- Pay close attention to hearing notices:
  - In-person,
  - Telephonic,
  - Video (from the courtroom), **or**
  - Online video teleconference (i.e. Zoom).

# COVID Update

- **In-person hearing** (in the courtroom)
  - **Courthouse**
    - Mask required
    - Compliance with District Court Special Order
  - **Courtroom**
    - Judge discretion for masking, etc.

# COVID Update

- **Telephonic hearings**

- Dial in at least 10 minutes before hearing
- Do not use speaker phone
- Headset microphone recommended
- Keep line muted when not talking
- Identify yourself each time you speak
- Do not record the call

# COVID Update

- **Video hearings** (in courtroom)
  - Same as in-person hearing requirements

# COVID Update

- **Online video teleconference hearings** (i.e. Zoom)
  - Court will send a **link via email**. You may be required to **download software** (only once).
  - You will be required to contact the court **in advance** to **test your connection** and device.
  - Ensure that you have a **good quality internet connection**.
  - Ensure that you have an **“adequate” device** (tablet, laptop, or desk top computer preferred)

# COVID Update

## Online video teleconference hearings (con't)

- Headset microphone preferred over computer microphone
- Connect at least 10-15 minutes before hearing to check connection, etc.
- Make sure that you are muted (and remember to unmute when you need to speak)
- Identify yourself each time that you speak
- Do not record the video or audio

### Transition to New Telephonic Hearing System

- Federal Judiciary will be transitioning away from ATT for telephonic hearings.
- Full transition required for all courts by **9/30/2022**.
- SD Miss will **transition to Microsoft Teams**.
- Individual hearing participants will continue to have option of “dialing in” to a telephone number.

  - 2) **General announcements** regarding court operations (i.e. Rules changes, court closure, etc.)

### Email Announcements and Notices

- Issue – not receiving email announcements/notices because recipient's internet service provider is blocking these emails as SPAM.
- Make sure that you email system/provider includes these email addresses on the "whitelist":

- Registered Filer enters email information into CM/ECF online system.
- A primary email address and a secondary email address may be entered.
- Both email addresses receive all official case notices.
- **Recommendation – use different email domains**

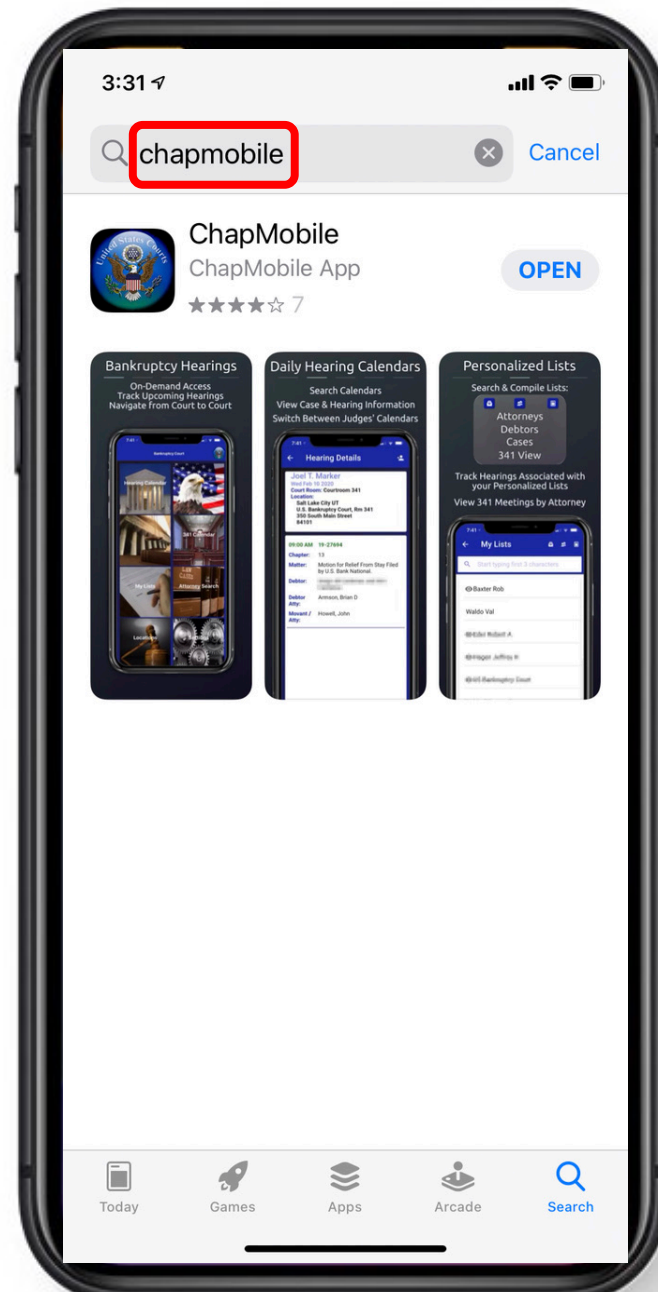
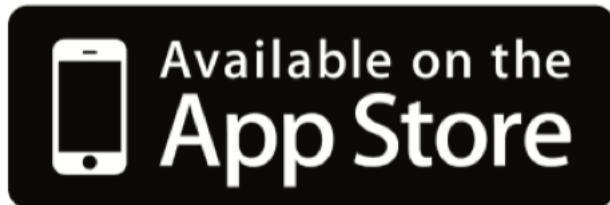

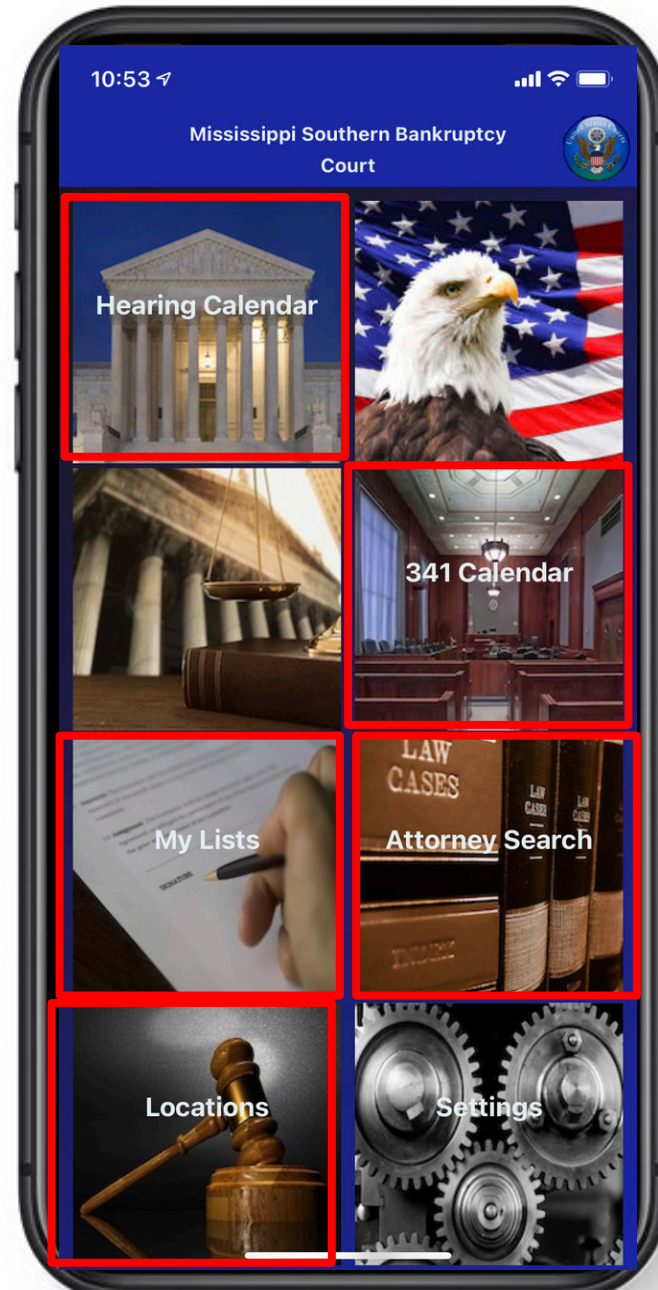
